



# Kingston Energy Storage Power Station Subsidy Policy

What is utilities Kingston doing to support Ontario's Energy Transition?

As an active participant in Ontario's energy transition, Utilities Kingston is supporting a long-duration energy storage project that would store electricity to be used in meeting peak demand.

What is the long duration energy storage Investment Support Scheme?

Long Duration Electricity Storage investment support scheme will boost investor confidence and unlock billions in funding for vital projects. The UK is a step closer to energy independence as the government launches a new scheme to help build energy storage infrastructure.

Is energy storage regulated?

Whilst the Department of Business, Energy & Industrial Strategy ("BEIS") and Ofgem have been supportive of energy storage and recognise the benefits and flexibility provided by the various technologies, there is no specific legislation on or regulation of storage at present.

What is the powering up Britain energy security plan?

2.10.11 The Powering Up Britain: Energy Security Plan [footnote 81] states that government seeks large scale ground-mount solar deployment across the UK, looking for development mainly on brownfield, industrial and low and medium grade agricultural land.

Who regulates electricity storage?

Ofgem is the relevant regulator for electricity storage, though as noted above there is no specific storage regulatory regime. Ofgem has recognised that there are regulatory changes required to enable the full commercial development of storage and it has committed to working with other stakeholders to consult on such changes.

What changes will the SMART plan make to electricity storage?

No specific changes for large-scale, long duration electricity storage. This means implementing the changes in the smart plan, such as innovation funding, and individual changes to remove market barriers for all types of storage.

The Powering Up Britain plan stated we will put in place an appropriate policy framework by 2024 to enable investment in LDES, with the goal of deploying sufficient storage capacity to balance...
