### How do you ship lithium ion batteries?

Goods must be labelled as "Lithium Ion Battery" or "Lithium Metal Battery" and include appropriate shipping marks and hazard labels. #### What are the shipping requirements for lithium batteries?

# How many lithium batteries can be shipped?

Only a maximum of fourcan be sent, with two per container, and each battery must have a rating of below 100 watts per hour. It is essential to note that some countries have their own regulations and restrictions for shipping lithium batteries, so it is crucial to check with the destination country's customs authorities before shipping.

### Can I ship a lithium ion battery by air?

For this reason, any battery that is suspected or known to be defective (swelling, corroding or leaking, for example) is not permitted for shipping within the DHL Express network.
