Who owns lakeside battery storage facility in North Yorkshire?

Global clean energy enterprise Tag Energy has increased its UK presence with the acquisition of a 100% stake in the Lakeside 99.9MW battery storage facility in North Yorkshire from independent renewable energy company RES.

Why did tagenergy acquire res battery storage facility?

TagEnergy acquires 99.9MW battery storage facility from RES as rapid growth in UK continues - TagEnergy generates and trades competitive, clean power to accelerate the energy transition.

What is new energy partnership?

New Energy Partnership, an experienced team backed by significant equity investment are targeting delivery of more than 2GW of Battery Energy Storage Systems (BESS) and renewable energy projects this decade to support the country's transition to Net Zero.

When did tagenergy enter the UK renewables market?

TagEnergy entered the rapidly expanding UK renewables market in 2021, with commencement of construction by TagEnergy and Tesla of the Hawkers Hill Energy Park battery storage facility in Dorset in September. In October, TagEnergy acquired the Roaring Hill Energy Storage Project in Fife, Scotland from Renewable Energy Systems (RES).

Does tagenergy own a 60% stake in a 50MW battery storage project?

Last month it acquired a 60% stake in two 50MW battery storage projects, one near Luton, England and one near Abernethy Scotland, in a joint venture with Harmony Energy. The five battery storage facility projects announced to date take TagEnergy's secured portfolio in the UK to 270MW /540MWh.
