What is the new battery regulation?

To respond to the growing demands, the EU has adopted a New Battery Regulation in July 2023, which replaces the previous Battery Directive from 2006 (EU Battery Directive 2006/66/EC). What is the new EU Battery regulation 2023/1542?

A new EU battery regulation, Regulation 2023/1542, was recently approved, and it will not only replace Battery Directive 2006/66/EC but also introduce requirements in many new areas of sustainability and safety of batteries and battery-operated products.

What are battery safety requirements?

These include performance and durability requirements for industrial batteries, electric vehicle (EV) batteries, and light means of transport (LMT) batteries; safety standards for stationary battery energy storage systems (SBESS); and information requirements on SOH and expected lifetime.

What are the requirements for a rechargeable industrial battery?

Performance and Durability Requirements (Article 10) Article 10 of the regulation mandates that from 18 August 2024, rechargeable industrial batteries with a capacity exceeding 2 kWh, LMT batteries, and EV batteries must be accompanied by detailed technical documentation.

When did battery regulation come into force?

The regulation came into force on 18 August 2023. Scope and application The regulation covers a wide range of batteries, including portable batteries, electric vehicle batteries, industrial batteries, and stationary battery energy storage systems.

What is the EU Battery regulation?

The EU Battery Regulation introduces robust measures to enhance transparency and traceability across the battery value chain. By implementing systems that make detailed battery information readily accessible, the regulation seeks to empower consumers, facilitate regulatory compliance, and ensure responsible production and recycling practices.
