

## **PSE Standards for Energy Storage Product Testing and Certification**

What is product safety of electrical appliances & materials (PSE) certification?

Product Safety of Electrical Appliances & Materials (PSE) certification is a compulsory market access system for electrical appliances in Japan, and an important component of Electrical Appliance and Material Safety Act (DENAN Act).

#### What is the PSE law in Japan?

The PSE Law and its regulations specify mandatory electrical safety and EMI requirements for electrical products sold in Japan. 457 product categories have been designated pursuant to the PSE Law (as of December 2018). Under the PSE Law, electrical products are divided into two risk-based categories.

#### What is PSE compliance testing?

See the JQA guide or METI guide for a detailed explanation of each step. Manufacturers are obligated to conduct PSE compliance testing to ensure their products comply with technical requirements. This requirement may be fulfilled by in-house testing and/or third-party testing, as needed.
